You have the right to make a complaint at any time to the Information Commissioner's Office (ICO), the UK supervisory authority for data protection issues (www.ico.org.uk). USEFULL INFORMATION

We may hold and process personal data that you provide to us in accordance with the DPA and GDPR. The information that we collect and store relation to you is primarily used to enable us to provide our services to you and meet our contractual commitments to you.

WHAT INFORMATION DO WE COLLECT

Personal data, or personal information, means any information about an individual from which that person can be identified. We may collect, use, store and transfer different kinds of personal data about you which we have grouped together follows:

- Transaction Data includes details about payments to and from you.
- Technical Data includes internet protocol (IP) address, browser type and version, time zone setting
 and location, browser plug-in types and versions, operating systems and platform and other
 technology on the devices you use to access the website. Normally you will only provide such details
 if you complete an online enquiry form or request an instant valuation.
- Usage Data includes information about how you use our website, products, and services.
- Marketing and Communication Data includes your preferences in receiving marketing from us and our third parties and your communication preferences.

Unless we have a legitimate interest, we do not collect any **Special Categories of Personal Data** about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health and genetic and biometric data).

HOW WE MAY USE YOUR PERSONAL DATA

We will only use your personal data when the law allows us to. Most commonly, we will use your data in the following circumstances:

Where you have consented to us holding and processing your data for a specific purpose

For example, to provide you with property updates and/or submitting your information to our recommended Solicitors/Financial Advisors upon your request.

Where we need to perform the contract, we are about to enter or have entered with you

For example, when registering you as a new Customer, when submitting your personal information to our referencing provider and/or providing your contact details to a third-party contractor.

Where data is held for you/our legitimate interests (or those of a third party)

For example, to make suggestions and recommendations to you about services which may be of interest to you and/or when asking you to write a review our service.

DISCLOSURE OF YOUR INFORMATION

We will disclose your personal information to third parties:

If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or, in order to enforce or apply our terms of use and other agreements; or to protect the rights, property, or safety of us, our customer, or others.

To enable us to comply with the law and to assist fraud protection and minimise credit risk.

Where you have consented for us to do so, to selected third parties who may contact you about their goods or services that you may be interested in, or require for the completion of our contractual obligations.

WHERE WE STORE YOUR PERSONAL DATA

The data that we collect from you may be transferred to, and stored at, a destination outside the European Economic Area (EEA). It may also be processed by staff operating outside the EEA who work for us or for one of our suppliers as we use remote website server hosts to provide the website and some aspects of our service - this is generally the nature of data stored in "the Cloud". This includes staff engaged in, among

other things, the processing of your payment details and the provision of support services. By submitting your personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

We will process, disclose or share your personal data only if required to do so by law or in the good faith that such action is necessary to comply with legal requirements or legal process served on us or the industry.
